Conditions of Participation, Disclaimer and Declaration of Consent for the Austria eXtreme Triathlon Association

As a participant, I am aware that participating in extreme endurance competitions, in particular an extreme triathlon, involves significant risks to life, health, and physical safety.

This includes, in particular, dangers from:

- physical and mental exhaustion,
- overexertion and medical emergencies,
- weather and environmental influences,
- road traffic and public traffic areas,
- natural and artificial obstacles,
- technical defects or equipment deficiencies,
- own and third-party fault,
- alpine or exposed route sections.

I am aware that within the scope of an extreme triathlon, physical and psychological stress up to personal performance limits can occur, and despite the greatest possible safety precautions, severe injuries or fatalities cannot be ruled out.

State of Health and Personal Responsibility

I expressly declare that I:

- have trained sufficiently for participation,
- am physically healthy,
- have a state of health appropriate for the competition,
- and have had this medically clarified or confirmed if necessary.

Participation is entirely at my own risk and responsibility.

Road Traffic Regulations (StVO)

I am aware that the provisions of the Austrian Road Traffic Regulations (StVO) apply without restriction on public roads and traffic areas. I commit to complying with all applicable legal regulations.

Mandatory Supporter

I am aware and expressly accept that starting in the Austria eXtreme Triathlon is only permitted with a registered supporter.

The supporter is responsible in particular for:

- support during the race,
- transporting personal equipment,
- as well as providing assistance regarding safety and supplies.

As a participant, I am fully liable for the behavior of the supporter.

Online Briefing and Race Information

I expressly confirm that both I, as a participant, and my registered supporter have fully watched, understood, and taken note of the online briefing provided by the organizer.

This includes in particular:

- safety instructions,
- route information,
- cut-off times,
- rules of conduct,
- supporter rules,
- traffic and environmental regulations,
- emergency procedures,
- as well as all competition-relevant guidelines of the organizer.

I commit, together with my supporter, to comply with all rules and instructions communicated in the briefing.

Ignorance of the contents conveyed in the online briefing does not relieve me or my supporter of responsibility or possible sanctions according to the regulations or conditions of participation.

Environmental and Fairness Rules

Throwing away or leaving behind rubbish or equipment outside the designated areas will result in disqualification without exception.

I commit to participating in the competition exclusively with technically flawless equipment that meets the requirements.

The instructions of the organizer, race management, volunteers, security personnel, and medical staff must be followed immediately at all times.

Exclusion from the Competition

I am aware and expressly agree that:

- in case of non-compliance with cut-off times,
- in case of safety-relevant behavior,
- in case of health risks,
- in case of violations of the regulations,
- or in case of non-compliance with instructions

exclusion from the competition may occur.

A doctor, paramedic, member of the race management, or the Austria eXtreme Triathlon Crew is entitled to prohibit my further participation at any time if there is a threat to my health or public safety.

Medical Treatment and Costs

I agree that in the event of necessary medical care or rescue, all resulting costs are to be borne exclusively by myself.

This includes in particular:

- medical care, rescue and recovery costs,
- hospital stays, transport costs, other consequential costs.

These services are not included in the entry fee and cannot be charged to the organizer, its volunteers, or partners.

Taking out private accident and liability insurance is expressly recommended.

It is the responsibility of the participant to have adequate insurance coverage.

Disclaimer of Liability

I waive all liability and claims for damages against the organizer, the Austria eXtreme Triathlon Association, its bodies, officials, volunteers, sponsors, partners, as well as landowners and authorities, provided these are not based on intent or gross negligence and can be legally excluded.

This includes in particular claims due to:

- injuries,
- health damage,
- property damage,
- financial losses,
- consequential damage,
- or fatalities.

This waiver also applies in favor of my relatives, heirs, legal successors, and other third parties.

Recourse and Indemnification Clause

Should the organizer be held liable by authorities, organizations, landowners, or other third parties due to my behavior or the behavior of my supporter, I commit to fully indemnifying and holding the organizer harmless in this regard.

This includes in particular:

- administrative penalties,
- fines,
- monetary penalties,
- trespassing/disturbance of possession,
- claims for damages,
- procedural and legal costs,
- as well as other resulting expenses.

I am jointly and severally liable together with my supporter for all their violations.

Theft and Property Damage

The organizer assumes no liability for:

- theft,
 - loss,
 - damage to equipment,
 - vehicles,
 - valuables,
 - or other property.

Force Majeure / Event Changes

I expressly accept that due to force majeure, official requirements, safety concerns, weather conditions, or other unforeseeable events:

- route changes,
- schedule changes,
- program changes,
- interruptions,
- or the cancellation of the event

are possible at any time.

This does not give rise to any claims against the organizer, in particular no claims for refunds, damages, or compensation.

Photo, Film, and Media Rights

I expressly agree that all:

- photos,
- video recordings,
- interviews,
- audio recordings,
- as well as other media content

created in connection with my participation in the Austria eXtreme Triathlon may be used, published, and processed by the organizer free of charge without any temporal, spatial, or factual restrictions.

This includes in particular the use for:

- print media, websites,
 - social media, press work,
 - advertising and marketing purposes,
 - as well as future event promotions.

Data Protection / GDPR

The contracting party agrees that the following personal data:

Severability Clause

Should individual provisions of this declaration be or become wholly or partially invalid or unenforceable, the validity of the remaining provisions shall remain unaffected.

Instead of the invalid or unenforceable provision, that legally permissible regulation shall be deemed agreed upon which comes closest to the economic purpose of the original provision.
